### General Description:

MANNA is a nonprofit organization in Philadelphia providing nutrition services to improve health for people with serious illnesses who need nourishment to heal. By providing medically tailored meals and nutrition education, we empower people to improve their health and quality of life.

MANNA is looking to hire a Registered Dietitian Nutritionist to join our Nutrition & Client Services Department. The RDN is a core member of the organization, providing Medical Nutrition Therapy services for the MANNA clients.

MANNA is an essential organization and remains open during the COVID-19 pandemic. We are currently following strict safety guidelines to keep employees and volunteers safe. The qualifying candidate for this position will report to the office and must show proof of full vaccination.

# Specific duties include:

- Assess medical and dietary history of clients to evaluate nutritional acuity to determine qualification for services and the best strategy for MNT interventions.
- Monitor laboratory values and medications with nutritional implications and respond with appropriate diet and educational interventions.
- Provide comprehensive, one-on-one nutrition education over the phone or virtually for clients suffering from life-threatening illnesses who are at acute nutritional risk.
- General food service responsibilities including kitchen audits, CQI checks and menu adherence
- Select or develop education materials and methods appropriate for individual clients.
- Create content for group nutrition education classes and deliver using virtual platforms. To return to on-site atmosphere after COVID-19.
- Participate in the Recertification process of existing clients to determine eligibility and length of stay on the MANNA program
- Develop and create nutrition focused blog and social media posts.
- Data entry of grant related nutrition counseling sessions and client progress.

- Work closely within the multi-disciplinary health care team to provide exceptional care.
- Act as a preceptor for nutrition interns during their community rotations at MANNA.
- Other duties as assigned.

# **Qualifications and Experience:**

- Registered Dietitian (RD)/Licensed Dietitian (LDN) in the state of PA or RD eligible.
- Strong oral and written communication skills.
- Bilingual in Spanish preferred but not required.
- Ability to work independently and as a team player, handle multiple priorities, and organize time effectively.
